(i) (a) For Group 'C' (Pay Level-2, Basic Pay- ₹19900) : 12th (+2stage) or its equivalent examination with not less than 50% marks in the aggregate from a recognized Board. 50% marks are not required for SC/ST/Ex-servicemen/Persons with Benchmark Disabilities (PwBD) candidates or where are candidates possess higher qualification i.e. Graduation/Post Graduation etc. from a Recognized University.

(ii) Separate Written Test will be organized for Group 'C' and erstwhile Group 'D' posts.

7. Minimum Qualifying Marks :-

(i) In Written Test, the candidate who will obtain 40% marks out of 60, will be eligible to be called for next stage of test i.e. Evaluation of Achievement Certificates.

(ii) The number of candidates to be called for next stage of test will be equal to 5 times of the number of vacancies of Scout/Guide. If more than one candidate will obtain equal marks as lowest cut-off marks among five times, all such candidates will be called for next stage of test.

(iii) 40% marks in aggregate (100 Marks) will be minimum qualifying marks for empanelment. **The panel will be formed purely on merit basis.**

5.3 Date of Birth filled by the candidate in the online application form and the same recorded in the Matriculation/ Secondary Examination Certificate will be accepted by this Directorate for determining the age and no subsequent request for change will be considered or granted.

5.4 Ex-servicemen who have already secured employment in civil side under Government in Group 'C' & 'D' posts on regular basis after availing of the benefits of reservation given to ex-servicemen for their re-employment are not eligible for reservation in Ex-SM category and fee concession. However, such candidates can avail of the benefit of reservation as ex-servicemen for subsequent employment if he immediately after joining civil employment, gives self-declaration/undertaking to the concerned employer about the date-wise details of application for various vacancies for which he had applied for before joining the initial civil employment as mentioned in the OM No: 36034/1/2014-Estt (Res) dated 14.08.2014 issued by DoP&T.

5.5 The period of "Call up Service" of an Ex-Serviceman in the Armed Forces shall also be treated as service rendered in the Armed Forces for purpose of age relaxation, as per rules.

5.6 For any serviceman of the three Armed Forces of the Union to be treated as Ex-Serviceman for the purpose of securing the benefits of reservation, he must have already acquired, at the relevant time of submitting his application for the Post/Service, the status of ex-serviceman or is in a position to establish his acquired entitlement by documentary evidence from the competent authority that he would complete specified term of engagement from the Armed Forces within the stipulated period of one year from the closing date for receipt of application. Such candidates must also acquire the status of an ex-serviceman within the stipulated period of one year from the closing date of receipt of applications.

5.7 Explanation: An 'ex-serviceman' means a person:

- 5.7.1 who has served in any rank whether as a combatant or non-combatant in the regular Army, Navy and Air Force of the Indian Union, and
- 5.7.1.1 Who either has been retired or relieved or discharged from such service whether at his own request or being relieved by the employer after earning his pension; or
- 5.7.1.2 Who has been relieved from such service on medical grounds attributable to military service or circumstances beyond his control and awarded medical or other disability pension; or
- 5.7.1.3 Who has been released from such service as a result of reduction in establishment;
- or
- 5.7.2 Who has been released from such service after completing the specific period of engagement, otherwise than at his own request, or by way of dismissal, or discharge on account of misconduct or inefficiency and has been given a gratuity; and includes personnel of the Territorial Army, namely, pension holders for continuous embodied service or broken spells of qualifying service;
- or
- 5.7.3 Personnel of the Army Postal Service who are part of Regular Army and retired from the Army Postal Service without reversion to their parent service with pension, or are released from the Army Postal service on medical grounds attributable to or aggravated by military service or circumstances beyond their control and awarded medical or other disability pension;
- or
- 5.7.4 Personnel, who were on deputation in Army Postal Service for more than six months prior to the 14th April, 1987;
- or
- 5.7.5 Gallantry award winners of the Armed forces including personnel of Territorial Army;
- or
- 5.7.6 Ex-recruits boarded out or relieved on medical ground and granted medical disability pension.
- 5.8 A Matriculate Ex-Serviceman which includes an Ex-Serviceman, who has obtained the Indian Army Special Certificate of education or corresponding certificate in the Navy or the Air Force certifying Essential Educational qualification prescribed the post, who has put in not less than 15 years of service with the Armed Forces of the Union shall be considered eligible for appointment to the reserved vacancies for Ex-SM in Group "C" posts. Thus, those non-graduate Ex-Servicemen who have not completed 15 years of service as on the closing date for receipt of applications or would not complete 15 years of service within one year from the closing date of receipt of applications are not eligible to apply for this examination.
- 5.9 Age relaxation/ EX-SM reservation is not admissible to sons, daughters and dependents of Ex-Servicemen. Therefore, such candidates should not indicate their category as ex-servicemen.
- 5.10 **ECONOMICALLY WEAKER SECTION (EWS) RESERVATION**
- Candidates who are not covered under the scheme of reservation for SC/ ST/ OBC and whose family gross annual income is below Rs.8 Lakh (Rupees Eight Lakh) are to be identified as EWS for benefit of reservation for EWS. The income shall also include income from all sources i.e. salary, agriculture, business, profession etc. for the financial year prior to the year of application i.e. 2022-23. Also candidates whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of family income:
- (i) 5 acres of agricultural land and above;

બ્રિટિશ પાર્લામેન્ટ દ્વારા લગભગ 200 વર્ષમાં ભારતને લગતા Hindu Personal Law, 1772, 'Thuggee' and Dacoit Suppressions Acts, 1836, Indian Slavery Act, 1843, Hindu Widow's Remarriage Act, 1856, Societies Registration Act, 1860, The Paper Currency Act, 1861, Indian Contract Act, 1872, Civil Procedure Code-1872, The Vernacular Press Act, 1878, Land Revenue Code, 1879, Negotiable Instruments Act, 1881, Transfer of Property Act, 1882, Indian Telegraph Act, 1885, Indian Press Act, 1910, Indian Forest Act, 1927, Hindu Inheritance (વારસાઈ) Act, 1928, Official Secrets Act, 1923, Indian Sale of Goods Act, 1930, Indian Partnership Act, 1932, Drugs and Cosmetics Act-1940, Industrial Disputes Act, 1947 વગેરે જેવા લાંબા ગાળાની અસર થાય તેવા કુલ 58 જેટલા મુખ્ય કાયદા પસાર કરવામાં આવ્યા હતા. તેનો દરેકનો હેતુ જુદો-જુદો હતો એટલે એ પ્રમાણે એ કાયદાનું નામ પ્રચલિત થઈ ગયું. જેમ કે બ્રિટિશ ઈસ્ટ ઇન્ડિયા કંપનીને ભારત સહિત પૂર્વના દેશો સાથે વેપાર કરવા માટે તારીખ 31.12.1600ના રોજ જે અધિકારપત્ર કે પરવાનો આપવામાં આવ્યો તેને ચાર્ટર એક્ટ કહેવાયુ. બ્રિટિશ સરકાર દ્વારા ત્યારબાદ કુલ 19 જુદા-જુદા ચાર્ટર એક્ટ પસાર કરવામાં આવેલ હતા. વિવિધ ચાર્ટર ઉપરાંત બ્રિટિશ સરકાર દ્વારા કંપની માટે વર્ષ 1615માં અને 1623માં "રોયલ ગ્રાન્ટ્સ" ઈશ્યુ કરવામાં આવેલ હતા. વર્ષ 1615ના રોયલ ગ્રાન્ટ મારફતે વહાણના દરેક કમાન્ડરને કર્મચારીઓ વહાણમાં કે દરિયામાં જો ગુનો કરે તો તેને મૃત્યુદંડ સહિતની સજા કરવાની સત્તા આપવામાં આવી. અને વર્ષ 1623 ના "રોયલ ગ્રાન્ટ" દ્વારા જો કંપનીના કોઈ કર્મચારી(ઓ) જમીન ઉપર પણ કોઈ ગુનો કરે તો મૃત્યુદંડ સહિતની સજા કરવાની સત્તા કંપનીને આપવામાં આવી. આમ, કંપનીને તમામ સત્તાઓ તાજ તરફથી મળતી હતી.

બ્રિટિશ ઈસ્ટ ઇન્ડિયા કંપનીની કામગીરીને નિયમિત કરવા (regulate કરવા) માટે જે કાયદા રચાયા તેને રેગ્યુલેટિંગ એક્ટ (નિયામક ધારો) કહેવાયુ. બાદમાં ભારત માટે ગવર્નર જનરલ ઇન કાઉન્સિલ એટલે કે ચાર સભ્યોની જે executive council (કારોબારી પરિષદ) બની તેની કામગીરીમાં જે ફેરફારો કરવા માટે કાયદો બન્યો તેને ઇન્ડિયન કાઉન્સિલ્સ (પરિષદ) એક્ટ કહેવાયું. છેલ્લે બ્રિટિશ હુકમતનો વ્યાપ વધારવા અને વહીવટમાં સુધારા કરવા, ભારતના બંધારણની રચના અને સ્વતંત્રતાને લગતા જે કાયદા બ્રિટિશ પાર્લામેન્ટમાં પસાર થયા તેને ગવર્નમેન્ટ ઓફ ઇન્ડિયા એક્ટ (શાસન અધિનિયમ) કહેવાયા.
