ELIGIBILITY CRITERIA :

 - Candidate shall have to secure minimum 50% Marks in Stenography/Skill Test.
- (b) Written Test (Objective Type MCQs):
(Tentatively scheduled on 27/06/2021 – IIInd Session)
- The Written Test (Objective Type MCQs) would be of 30 Marks (Duration : 45 Minutes), each Question of 1 Mark.
 - Syllabus for Written Test : General Knowledge, General English, Current Affairs, Numerical & Mental Ability etc.
